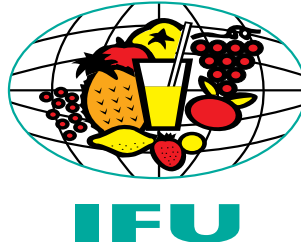

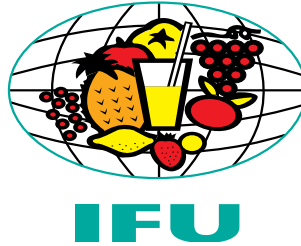

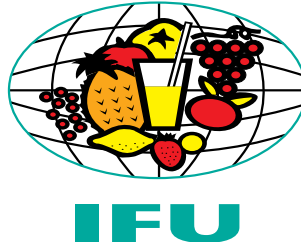
## C. Orders

- 3) Enter your details in the order sheet and validate.

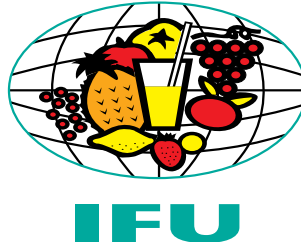
### **E. Payment method**

## **H. Data**

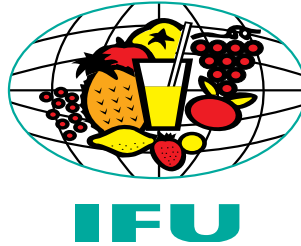
1) By leaving your details in order to fulfil your Order, you undertake not to wrongfully assume the identity of any other person or to use a false name.

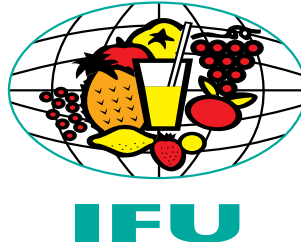
## K. Liability
